Thank you for your email on Monday 05 August 2024 in which you requested information under the Official Information Act 1982. You requested:

"The total amount co-funded in each of the last three years across the public sector for EV charger installation projects. For example, see the attached from the Ministry of Education which notes that EECA co-funded 50% of the cost of the projects. Please break this down by recipient organisation."

You will find the information you requested from EECA attached to this letter. Please note the associated caveats that relate to the information presented within the table.

- The dollar values presented below reflects the maximum committed co-funding amount that can be
 claimed and paid to the public agency on completion of the installation and the year denotes the year in
 which the co-funding contracts were signed and committed to (please note this is distinct from the actual
 date installation project costs are incurred).
- The proportion of committed EECA co-funding varies per contract, but the maximum amount funded per charger is 50% of the project costs or \$5000, whichever is the larger amount.
- The dollar values provided are the contractual maximum co-funding amount that each agency would be
 able to claim from EECA for EV charger installation under those contracts. EECA then reconciles project cofunding claims against the project's related invoices before payment is provided to that public agency.
